Revenue drive: The good, the bad and the ugly!!

However what does not seem to have an ending are the ingenious and time-tested methods resorted to by Excise officers to project in their statistical reports improved augmentation of Revenue in PLA.

d) All exports will be done only under Rule 18 of Central Excise Rules 2002 i.e on payment of duty. The catch - Payment of duty should be through PLA only.

Overheard a "Senior Officer" in conversation with his "favourite" Superintendent, "If my posting is at stake (Taxindiaonline carried the news of non-performing officers to bear the burnt in the next AGT), I don't care about yours (read posting). Any further exports under Bond / LUT from your Range and you find yourself in Statistics"-- May be, in hindsight, the hassled Superintendent should have mustered some guts to quote Finagle's Fourth Law – "Once a job is fouled up, anything done to improve it only makes it worse".

THE UGLY

- e) In hushed tones, assessees are requested to deposit large amounts in PLA. All such deposits in PLA will also be shown as duty collected in PLA in the last month of the current financial calendar. Needless to add, the same amount will be repeated in the statistical jargon in the coming year as 'actual debits'. Budget projects the total receipts (tax, non-tax and Capital receipts) and almost half of such receipts are generally expected to come from tax revenue. If such manipulated figures continue to be part of our Budget exercise, this important policy tool will be sadly rendered redundant.

Hopefully, there is a Happy Ending to this story – March 31st – PLA payments will be

augmented – May be, couple of "zeroes" are added to "the actuals" – The Cenvat payment will be shown zero !!! The bosses are happy ... All's well that ends well !!!!

b) Scene I : An audit Superintendent in conversation with an ' officer friendly assessee"

Superintendent : Dekho – Sab teek hai! Lekin , we have to show some performance -- Boss , wants recovery from every company!!!

Assessee : Bolo Sir, can we help you in some way – Lekin , hamara Nuksaan nahin hona !!!

Superintendent: I am here , don't worry – In your Cenvat Register for yesterday's entry in Cenvat credit , add one zero i.e you have taken credit of Rs 2, 10,000 /- . Add one zero . Make it Rs 21,00,000/- . I will point out the same. You will reverse the extra amount – Almost Rs 18 lakhs will be credited to my performance ... No problem for you !! No show cause notice – No payment of interest ---

Assessee: Kya baat hai Sir, Ekdum Badiya --- Done, Sir !!! Done -

Scene II: Monthly recovery position is being reported

Superintendent: Rs 32 lakhs from two units.

Deputy Commissioner : That is good and fast – Within three days, Rs 32 lakhs recovered .. Very good !!!
