Madras High Court stops the war on interest. Holds, proposed amendment to Sec. 50 of GST Act is clarificatory and hence retrospective and hence interest is payable only on net liability.

(i) the era of GST is in a nascent stage and both the Department as well as assessees are still learning the ropes

(ii) a rigid view should thus not be taken in matters involving procedural requirements such as availment of credit;

#### January 2020 stands second highest monthly collection since implementation of GST

The gross GST revenue collected in the month of January, 2020 is ₹ 1,10,828 crores of which CGST is ₹ 20,944 crores, SGST is ₹ 28,224 crores, IGST is ₹ 53,013 crores (including ₹ 23,481 crores collected on imports) and Cess is ₹ 8,637 crore (including ₹ 824 crore collected imports).

The total number of GSTR 3B Returns filed for the month of December up to 31st January, 2020 is 83 lakhs.

#### Important to note:

- 1. Those regular taxpayers who have aggregate turnover of more than Rs. 2 crore are mandated to file GSTR 9. For the rest, filing of GSTR-9 is optional.
- 2. For filing of GSTR-9, filing of all due GSTR-1 and GSTR-3B is compulsory.
- 3. Those who have not filed GSTR-9, will not be able to file GSTR-9C.
- 4. Apart from above, 32.92 lakhs taxpayers who are not mandated to file GSTR 9, have filed it.
- 5. Similarly, apart from above, 1.04 lakhs taxpayers who are not mandated to file GSTR 9C have filed the same.
